

ROUTE 88A, NORTH SHORE EXPRESS

OPERATOR'S GUIDE

WESTBOUND: Kamehameha/Acacia to Turtle Bay Resort to AMC

DISPLAY "88A EXPRESS Wahiawa, North Shore, Ala Moana,"

operate **LOCAL** service from Kamehameha Hwy, **merge** to the far left lane after passing stop at Acacia onto Farrington,

If into LCC bus stop, continue on Farrington,

merge to the far right lane onto Kamehameha Hwy, **rt** California,

merge to the far left lane after passing Lehua,

If into the Wahiawa Transit Center to Stop 3,

exit rt Center,

If Cane,

If Kilani,

rt Kamehameha Hwy,

If to continue on Kamehameha at Kamehameha Hwy/Leong By-pass Rd intersection onto Weed Circle,

exit rt to remain on Kamehameha,

If at Kamehameha Hwy/Leong By-pass Rd intersection to remain on Kamehameha,

If Kuilima Dr (Turtle Bay Resort), pass guard shack,

rt into Parking Lot C,

rt into parking area immediately along Kuilima Dr,

DISPLAY "88A EXPRESS ALA MOANA VIA KAHEKILI,"

operate **LOCAL** service via **If** at first left through parking area,

If to exit parking lot,

If onto Kuilima Dr pass guard shack,

If Kamehameha,

continue onto Kahekili after passing stop at Kamehameha/Kahekili (Hygienic Store),

continue **LOCAL** service along Kahekili,

veer rt Likelike,

merge If two lanes to continue on Likelike,

merge If to take on-ramp to H-1 EAST after passing stop at School,

onto H-1 EAST,

take EXIT 21A "PALI HWY,"

rt Pali to Pali/Vineyard,

continue to operate **LOCAL** service via Pali,

merge If one lane to continue on Pali after passing stop at Vineyard onto Bishop,

cross Ala Moana Blvd to Aloha Tower Dr,

If Aloha Tower Dr,

merge onto Ala Moana Blvd,

merge to the far left lane after passing stop at Ala Moana/Queen,

If Piikoi,

rt Kona to terminus at Kona/Piikoi.

<p>EASTBOUND: Ala Moana Center/Kona to Turtle Bay Resort to Wahiawa Transit Center</p>	
<p>DISPLAY "88A EXPRESS - NORTH SHORE WAHIAWA TC," operate LOCAL service via Kona, rt onto Mahukona, rt Atkinson, rt Ala Moana Blvd onto Nimitz, rt Alakea, operate EXPRESS service via Alakea, merge If three lanes after passing stop at Hotel onto Queen Emma, If Kukui, rt Pali Hwy (<i>finish in left turn lane</i>), If Vineyard (<i>service stops at Liliha/Palama</i>), merge to the far left lane after passing stop at Palama, take on-ramp to H-1 WEST, take EXIT 20A "LIKELIKE HWY" to stop at Likelike/School, merge If one lane to continue on Likelike, take EXIT to "KAHEKILI HWY" onto Kahekili, service ALL BUS STOPS from Kahekili/Kulukeoe, continue on Kahekili, onto Kamehameha Hwy, rt Kuilima Dr (Turtle Bay Resort), pass guard shack, rt into Parking Lot C, rt into parking area immediately along Kuilima Dr, operate LOCAL service via If at first left through parking area, If through first row of parking stalls, If to exit parking lot, If onto Kuilima Dr pass guard shack, rt Kamehameha Hwy, rt to continue on Kamehameha at Kamehameha/Leong By-pass Rd intersection onto Weed Circle, exit rt to continue on Kamehameha after passing stop at Weed Circle, If Kilani at 7-Eleven, rt Cane, rt Center at next right, If into the Wahiawa Transit Center to Stop 6.</p>

<p><i>Car House to Starting Points</i> Ala Moana Center-Kona: Rt Kuala, onto Moanalua Rd, take on-ramp to H-1 EAST, take EXIT 21B "PUNCHBOWL ST," onto Punchbowl, lf King, rt Pensacola, lf Waimanu, lf Piikoi, rt Kona. Kamehameha/Acacia: Rt Kuala, rt Waimano, right Kamehameha to Kamehameha/Acacia.</p>	
<p><i>Finish Points to Car House</i> Ala Moana Center-Kona: Kona, lf Mahukona, lf Kapiolani, rt Piikoi, lf Lunalilo, onto H-1 WEST, Moanalua Fwy (via Red Hill), H-1 WEST, take EXIT 10 "PEARL CITY/WAIMALU," rt Moanalua Rd, onto Kuala, lf into Facility. Wahiawa Transit Center: Rt California, lf Kamehameha, take on-ramp to H-2, EXIT 1B "WAIANAE", take "WAIPAHU/PEARL CITY" EXIT, rt Waipahu, rt Kamehameha, take "PEARL CITY" off-ramp, onto Farrington, onto Kamehameha, lf Acacia, rt Kuala, rt into Facility.</p>
